North Carolina English Language Arts Standard Course of Study

PLEASE NOTE: This document provides the standards adopted April 2017 for implementation 2018-19. The final standards document (available September 2017) will include clarifications and a glossary (see example below). A clarification will include suggestions for instruction, explanations, and examples. E.g.’s that were once included within the standards will now be a part of the clarification. The glossary will be consistent K-12 and will include the bolded words shown throughout this document.

Standard	Clarification	Glossary
<p>RL.7.4 Determine the meaning of words and phrases as they are used in a text; analyze the impact of rhymes and repetitions of sounds on meaning and tone in a specific line or section of a literary work.</p>	<p>Students examine the text to understand the meaning of words or phrases using the context to inform their thinking. Students consider rhymes and repeated sounds such as alliteration and assonance as author’s craft. Students recognize these literary devices and then explain how they contribute to meaning and tone.</p> <p>Ideas for Instruction:</p> <p>As students read, they underline unfamiliar words. The teacher models how to use the words they know to determine the meaning of the ones they don’t know (think aloud).</p> <p>Teachers could read aloud and use audio so students hear rhymes and repetitions. Ask students what feelings are evoked that influence the tone and the meaning.</p> <p>Students recognize rhymes and repetition of sounds in a familiar nursery rhyme or popular song and revise the rhymes or repetitions to create a different tone.</p>	<p>Tone is the author’s attitude towards a topic which is conveyed through the words he/she deliberately chooses. Examples of tone include judgmental, sarcastic, and comical.</p>

Reading Strand: K-12 Standards for Reading define what students should understand and be able to do by the *end of each grade*. Students should demonstrate their proficiency of these standards both orally and through writing. For students to be college and career ready, they must read from a wide range of high-quality, increasingly challenging literary and informational texts. One of the key requirements of the Standards for Reading is that all students must be able to comprehend texts of steadily increasing complexity as they progress through school. Students should also acquire the habits of reading closely and independently for sustained periods of time. They need to connect prior knowledge and experiences to text. They must also show a steadily growing ability to discern more from and make fuller use of text.

Reading Foundational Skills: The foundational skills are directed toward fostering students’ understanding and working knowledge of concepts of print, the alphabetic principle, and other basic conventions of the English writing system, including handwriting. Language Standards 1 and 2 were revised to include two continuums, one for grammar and one for conventions. The skills within each continuum are arranged by grade band rather than by grade to allow for multiple years of practice, differentiation, and scaffolding, as needed. In the lower grade of the band, the teacher is introducing and modeling the skill. In the higher grade of the band, students are applying the skill to more complex text, as they work toward mastery. A continuum guide is being developed and will be available January 2018.
